

### APPLY FOR UNIVERSITY SCHOLARSHIPS IN FOUR EASY STEPS

### Introduction

Each year, millions of dollars in scholarships are awarded to students by various organisations such as tertiary institutions, Government, societies and businesses.

There are many types of scholarships, which have different eligibility criteria, selection criteria, and methods of applying. There isn't a central resource you can use to find every single scholarship you may be eligible for.

You will need to take time to search through:

- Government websites
- Tertiary institute websites and scholarship brochures
- Good Universities Guide scholarship portal, www.gooduniversitiesguide.com.au/scholarships
- Internet search engines
- Tertiary Admissions Centres websites and scholarship brochures

This may take you a considerable amount of time, but it will be worth it if you can secure a scholarship, especially if you have to move away from home to study.

The following is four steps you can take to research your scholarships options.

# **STEP 1** SERVICES AUSTRALIA



If you are planning to study at university or TAFE full time, you may be eligible for financial support from Services Australia in the form of payments, a loan, a scholarship, or one-off payment, https://bit.ly/3NLZd3u

**Payments**: you may be eligible for a payment such as Youth Allowance or ABSTUDY, or you may currently receive one of these payments. Your eligibility will depend on a number of factors which may include your:

- parent/s combined income, assets and means.
- income, savings, assets and means.
- location and if you are living at home.

**Loan and scholarship**: If you're eligible for Youth Allowance or ABSTUDY Living Allowance, you may be eligible for the Student Start-up Loan or the Relocation Scholarship (information is listed below).

**Tertiary Access Payment**: is a one off payment of up to \$5000 if you have to move away from a regional or remote area to study.

#### Student Start-up Loan

If you're a university student, you can apply for a tax free Student Start-up Loan up to twice a year (2023 rate = \$1,201).

You must be receiving a benefit such as Youth Allowance or ABSTUDY Living Allowance.

You apply to Centrelink for this loan and you will have to pay it back once you start earning a certain amount of income.

#### **Relocation Scholarship**

If you have to move away to study your course either from or to a regional area, you may be eligible for the annual Relocation Scholarship.

To be eligible, you must be receiving the dependant rate of Youth Allowance, have a special reason why you receive the Independent Youth Allowance, or receive ABSTUDY (in some circumstances).

If you are eligible, you will receive this scholarship automatically, so you won't need to apply for it.

# **STEP 2** TERTIARY ADMISSION CENTRES



You can apply for scholarships via some state-based tertiary admission centres. Below is information for Victoria and New South Wales/Canberra.

#### Victorian Tertiary Admissions Centre (VTAC) – Victorian courses

The majority of university courses in Victoria are applied for via VTAC. Most universities enable you to apply for access and equity, Commonwealth Indigenous, and academic merit scholarships through completing the Scholarships form on the VTAC website.

The form collects personal information that assists the universities to assess your eligibility.

Australian Catholic University, University of Melbourne, and Federation University have alternative application methods.

#### **Application Process**

- From Monday 31 July, create a VTAC account via www.vtac.edu.au and apply for at least one course (timely applications close Thursday 28 September).
- Within your VTAC account, click on the Scholarships link.
- Fill out each section and click submit
- Post any evidence required to VTAC by Friday 6 October using the correct cover sheets or upload it to your account.

#### Universities Admissions Centre (UAC) NSW and Canberra courses

The majority of university courses in NSW and ACT are applied for via UAC. Participating universities enable you to apply for their equity scholarships via UAC through completing the online Equity Scholarships form.

The form collects personal information that assists the universities to assess your eligibility.

Note: if you applied directly to a university through an early entry program, you may still need to apply for some of the institutes scholarships via UAC. For example, Charles Sturt University and University of Wollongong.

#### **Application Process**

- Apply for courses via www.uac.edu.au (timely applications close 29 September).
- Complete the Equity Scholarships application form via UAC and save your Equity Scholarships ID and pin
- Upload required documents and evidence by 8 December for the December Round 2 offer round.

### **STEP 3** INSTITUTION SCHOLARSHIPS



Each institution you apply for will have scholarships listed on their website. You simply put the name of the institution and the word 'scholarships' into an Internet search engine and the link should come straight upe.g., "RMIT scholarships".

You will need to search through the scholarships that are relevant to you. These could includeundergraduate, faculty (e.g., health), campus, memorial, bequeathed, accommodation etc.

You will need to read over each one, checking the eligibility criteria and how to apply. There will be different closing dates and methods on how to apply for each university.

#### Steps

Set up an Excel file or Word document and set headings such as university name, scholarship name, eligibility, open date, close date, documents/evidence required, application method. Then do the following to find the scholarships.

- Go to the scholarships homepage of the institutions you've applied to and explore your options. If you find a scholarship, research how to apply for it.
- If it says you have to apply via VTAC or UAC, you have already done this through step 2.
- If you need to apply for the scholarship directly to the university, you may have to apply via an application form or online portal.
- Use your Excel file or Word document to keep on track.

### **STEP 4** OTHER SCHOLARSHIPS



Once you've exhausted your options through Centrelink, Tertiary Admission Centres, and the institutions you have applied for, you will need to find other scholarships floating around in cyber space. A central scholarships database is available through the Good Universities Guide website, http://bit.ly/1lm4WPd
